Earlier this week, the Ohio Department of Health updated the quarantine and testing guidelines regarding students in Ohio schools that come into contact with someone diagnosed with COVID-19. The Hamilton Co. Dept. of Health has also approved this change for school districts in our county, including SLSD.

Citing national information and data derived from a pilot program in Warren County, the Ohio Department of Health has offered a *Mask to Stay* and *Test to Play* policy for K-12 students in our state. It is important to note, that this is an option for close contacts. The other option would be to continue with a traditional quarantine where one would stay home for 7-14 days, which is what has been happening the last 18+ months. The below options involve masking for a short period after being a close contact to a positive and taking a PCR test 5-7 days after exposure. The most important piece of this new option is that it allows the student to **stay in school vs. quarantining at home.** 

## The Mask to Stay Policy (in-school):

- \*Students may remain in the school environment if they wear a mask properly for 14 days after exposure.
- \*Self-monitor for COVID-19 symptoms, then isolate and get tested if student shows symptoms of COVID-19.
- \*Isolate and get tested if COVID-19 symptoms occur.
- \*Students can discontinue quarantine procedures on day 8 if they show no symptoms and have a negative PCR or proctored home test between days 5-7 following exposure. Documentation will need to be provided to the school nurse.
- \*Noncompliance with this policy will result in following the standard/traditional quarantine guidelines.

## The Test to Play Policy; (extra-curricular activities):

- \*Asymptomatic contacts can participate in school activities if they wear a mask when able, like riding on a team bus, in a locker room or on the sideline.
- \*Test upon initial identification as a close contact.
- \*Test again at days 5-7 after exposure.
- \* Students can discontinue quarantine procedures on day 8 if they show no symptoms and have a negative PCR or proctored home test between days 5-7 following exposure. Documentation will need to be provided to the school nurse.
- \*Noncompliance with this policy will result in following the standard/traditional quarantine guidelines.

Students that have worn a mask properly or are fully vaccinated, do not need to follow either of the above options.

The Ohio Department of Health also speaks to the importance of it **being the parents' responsibility to monitor** for the following symptoms, associated with COVID-19. If our school nursing team observe the below symptoms being exhibited in students, they will act accordingly as well:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue, muscle or body aches
- Headaches
- New loss of taste or smell
- Sore Throat
- Congestion or runny nose
- Nausea or vomiting, diarrhea

Students who come into contact outside school should follow standard / traditional quarantine guidelines.
